

Software License Agreement

End User License Agreement (EULA) for the DIC Application

Effective Date: 14 October 2024 | Last Updated: 29 June 2026

1. License Grant

Subject to your compliance with this Agreement, Awakened Audioworks grants you a personal, non-exclusive, non-transferable, revocable license to use the Digital Interface with Consciousness (DIC) software ("Software") on the Android device on which it is pre-installed and pre-activated, solely for your personal, commercial, and non-medical use with a Booster and any Conduit.

2. Restrictions

You may not:

- Copy, modify, or create derivative works of the Software including any .X Files.
- Reverse engineer, decompile, or disassemble the Software.
- Rent, lease, sell, sublicense, assign, or otherwise transfer the Software to a third party unless permission to do so has been expressly obtained in writing to: AWAKENEDAUDIOWORKS@GMAIL.COM.
- Remove or alter any proprietary notices on the Software.
- Use the Software to interface with hardware other than an authorized Conduit, unless permission has been obtained verbally from an authorized technical support provider via +1 234 200 6697.

3. Ownership

The Software, including the patented BIRDSONG algorithm, the .X File format and the Main Matrix categorization system, and all related code, documentation, and trademarks, is and remains the exclusive property of Awakened Audioworks and its licensors. This Agreement does not grant you any ownership interest in the Software.

4. Updates

Awakened Audioworks may provide updates to the Software from time to time. Updates may be installed automatically or may require your action. This Agreement applies to all updates unless a separate license accompanies the update.

5. User-Created .X Files

DIC allows you to create your own avatar, upload a profile picture, and design your own .X Files which are instructions for frequency emission sets. As between you and Awakened Audioworks,

you retain ownership of any .X Files you author. You can sell, share, copy and redistribute any .X Files you have created. You are solely responsible for the legality and safety of any .X File you create or share with other users.

Awakened Audioworks does not copy, read, synchronize or store in the Cloud (server-based via internet protocol) any of your .X Files or any of your digital data. If you delete your .X Files or if your phone crashes, that data could be irrevocably lost. Always back up your .X Files in a safe location. Please read the Privacy Policy on the website for details.

6. Third-Party Components

The Software may include third-party or open-source components, which are licensed under their own terms. The Software may need to rely upon third-party Software Applications in order to process some of your data, e.g. Typeless Software Application for processing voice-to-text entries in the DIC.

7. Term and Termination

This Agreement remains in effect until terminated. Any updates published on the Awakened Audioworks website are an automatic update to this Agreement, and your continued use of DIC serves as your consent and agreement to the changes and updates to this Agreement.

Awakened Audioworks may terminate this Agreement if you breach any term. Upon termination, you must stop using the Software. Sections 3, 8, 9, and 10 survive termination.

8. Export Compliance

You agree to comply with all applicable export and re-export control laws and regulations, including those of the United States, United Kingdom, and European Union in your use and distribution of the Software.

9. Disclaimer of Warranties

The Software is provided “as is” without warranty of any kind, to the maximum extent permitted by law. Awakened Audioworks does not warrant that the Software will be error-free or uninterrupted.

10. Limitation of Liability

To the maximum extent permitted by law, Awakened Audioworks' total liability arising from this Agreement will not exceed the amount you paid for the product associated with the Software license, if any, nor to exceed any reasonable amount under otherwise comparable circumstances.
